

MINUTES OF THE REGULARLY SCHEDULED  
CLASSMATE MEETING OF JULY 15, 2010

**CALL TO ORDER:** **Farias** Chairman **Farias** called the meeting to order at 6:36 P.M.

**TREASURER'S REPORT:** **Rego** **Rego** reported that our "kitty/fund" was at \$1,217.00, and that number included donations of \$102.00 to the kitty/fund by Golfers at the June Golfing Event at Waialae Country Club. **Rego** also stated that the kitty/fund would be decreased, in the future, by an amount (not yet determined) equal to the subsidizing of Christmas Party Dinner costs. After floor discussions, it was also noted that the kitty/fund would also decrease by an amount (not yet determined) equal to the subsidizing of the reunion dinner cost(s) at Las Vegas, in September.

**OLD BUSINESS:**
